Scope of Declaration:

Under its own responsibility, Valmex S.p.A. hereby declares:

- i) to be fully informed on the European regulation 1907/2006/EC (REACH) and relevant implementation and constant updating (Registration, Authorization, Notification, Candidate List and SVHC);
- to be deemed responsible, pursuant to article 33 (1) of REACH regulation, for the information on the substances covered by - or likely to be included in - the Candidate List or Annex XIV which may be contained in the products supplied;
- k) to undertake, as of 01/12/2008, to verify the actual pre-registration in the company supply chain of the substances contained in the products that are being and will be supplied, so as to ensure a continuous supply to customers; The company shall also undertake to verify the actual registration of the above-mentioned substances, pursuant to the terms envisaged by REACH regulation;
- I) that the articles supplied shall not intentionally release substances;
- m) that the articles supplied do not contain substances or mixtures subject to restrictions on manufacturing, placement on the market and use, nor do they contain substances or mixtures in concentrations greater than the limit value set out in restriction conditions (Annex XVII);
- n) that the articles supplied do not contain any of the substances included in Annex XIV;
- o) that the articles supplied do not contain the substances included in the SVHC Candidate List or that, should they be present, their concentration is nonetheless less than 0.1% by weight (as per latest update) and they are marketed to an extent not greater than 1 ton per year.
- p) Pursuant to art. 9, par. 1(i) of the Waste Framework Directive amended by Directive 2018/851, some components falling within the definition of articles pursuant to art. 3 of REACH regulation fall within the conditions for notification in the SCIP database.
